



NOMINATE MARES TO FOAL IN 2017

FIRST PAYMENT DUE March 1, 2017 (NOT ACCEPTED IF POSTMARKED LATER THAN MIDNIGHT OF DUE DATE)

2019 BUFFALO STAKES - Purse \$25,000E

Buffalo Stakes for 2-year-olds foaled in Manitoba in 2017. By subscription of \$30 each for mares served in 2016 to accompany the nomination form by March 1, 2017. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$50 due by March 1, 2018. Third subscription of \$80 due by March 1, 2019. Fourth subscription of \$100 due 2nd Tuesday in May of 2019, with an additional \$120 due at time of entry and \$120 to start.

Distance: One Mile.

2020 JOHN W. SIFTON STAKES (for colts & geldings) or 2020 R.C. ANDERSON STAKES (for fillies) - Purse \$25,000E

J.W. Sifton Stakes for 3-year-old colts & geldings or R.C. Anderson Stakes for 3-year-old fillies, foaled in Manitoba in 2017. By subscription of \$30 each for mares served in 2016 to accompany the nomination form by March 1, 2017. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$50 due by March 1, 2018. Third subscription of \$60 due by March 1, 2019. Fourth subscription of \$80 due March 1, 2020. Fifth subscription of \$100 due second Tuesday in May of 2020 with an additional \$90 due at time of entry and \$90 to start.

Distance: Colts & Geldings - One and One Eighth Miles. Fillies - One Mile.

Non nominated horses may be made eligible to the 2020 Sifton or 2020 R.C. Anderson, by payment to CTHS office of 1% of the purse plus all missed nomination fees due the 2nd Tuesday in May 2020, or 10% of the purse at time of entry, to the race office, in addition to the enter and start fees.

2020 FRANK ARNASON SIRE STAKES (for colts & geldings) or 2020 HAZEL WRIGHT SIRE STAKES (for fillies) - Purse \$25,000E

F. Arnason Sire Stakes for 3-year-old colts & geldings or Hazel Wright Sire Stakes for 3-year-old fillies, foaled in 2017 and sired by stallions registered to the Manitoba Stallion Program. By subscription of \$10 each for mares served in 2016 to accompany the nomination form by March 1, 2017. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$20 due by March 1, 2018. Third subscription of \$30 due by March 1, 2019. Fourth subscription of \$50 due March 1, 2020 with an additional \$190 due at time of entry and \$200 to start.

Distance: 6 Furlongs.

Non nominated horses may be made eligible to the 2020 Frank Arnason Sire Stake or 2020 Hazel Wright Sire Stake, by payment to CTHS office of 1% of the purse plus all missed nomination fees due the 2nd Tuesday in May 2020 or 10% of the purse at time of entry, to the race office, in addition to the enter and start fees.

CONDITIONS: If a mare nominated to any of the above stakes has a dead foal, or more than one foal, is barren, or the foal dies at birth, the entry of such a mare is void and the nomination fee shall be returned to the subscriber. Transfer of ownership of any entry must be reported promptly. All stake races are contingent on funding.
