



# NOMINATE MARES TO FOAL IN 2020

FIRST PAYMENT DUE March 3, 2020 (NOT ACCEPTED IF POSTMARKED LATER THAN MIDNIGHT OF DUE DATE)

## 2022 BUFFALO STAKES - Purse \$30,000E

**Buffalo Stakes for 2-year-olds foaled in Manitoba in 2020.** By subscription of \$30 each for mares served in 2019 to accompany the nomination form by March 3, 2020. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$50 due by March 1, 2021. Third subscription of \$80 due by March 1, 2022. Fourth subscription of \$100 due 2nd Tuesday in May of 2022, with an additional \$120 due at time of entry and \$120 to start.

**Distance: 1 Mile.** *Non nominated horses may be made eligible by payment to CTHS office of 1% of the purse plus all missed nomination fees due the 2nd Tuesday in May 2022, or 10% of the purse at time of entry, to the race office, in addition to the enter and start fees.*

## 2023 JOHN W. SIFTON STAKES (for colts & geldings) or 2023 R.C. ANDERSON STAKES (for fillies) - Purse \$30,000E

**J.W. Sifton Stakes for 3-year-old colts & geldings or R.C. Anderson Stakes for 3-year-old fillies, foaled in Manitoba in 2020.** By subscription of \$30 each for mares served in 2019 to accompany the nomination form by March 3, 2020. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$50 due by March 1, 2021. Third subscription of \$60 due by March 1, 2022. Fourth subscription of \$80 due March 1, 2023. Fifth subscription of \$100 due second Tuesday in May of 2023 with an additional \$90 due at time of entry and \$90 to start.

**Distance: Colts & Geldings - One and One Eighth Miles. Fillies - One Mile.**

*Non nominated horses may be made eligible to the 2023 Sifton or 2023 R.C. Anderson, by payment to CTHS office of 1% of the purse plus all missed nomination fees due the 2nd Tuesday in May 2023, or 10% of the purse at time of entry, to the race office, in addition to the enter and start fees.*

## 2023 FRANK ARNASON SIRE STAKES (for colts & geldings) or 2023 HAZEL WRIGHT SIRE STAKES (for fillies) - Purse \$30,000E

**F. Arnason Sire Stakes for 3-year-old colts & geldings or Hazel Wright Sire Stakes for 3-year-old fillies, foaled in 2020 and sired by stallions registered to the Manitoba Stallion Program.** By subscription of \$10 each for mares served in 2019 to accompany the nomination form by March 3, 2020. To continue the eligibility for foals of mares nominated, the following additional payments must be made. Second subscription of \$20 due by March 1, 2021. Third subscription of \$30 due by March 1, 2022. Fourth subscription of \$50 due March 1, 2023 with an additional \$190 due at time of entry and \$200 to start. We reserve the right to make changes including combining the races.

**Distance: 6 Furlongs.**

*Non nominated horses may be made eligible to the 2023 Frank Arnason Sire Stake or 2023 Hazel Wright Sire Stake, by payment to CTHS office of 1% of the purse plus all missed nomination fees due the 2nd Tuesday in May 2023 or 10% of the purse at time of entry, to the race office, in addition to the enter and start fees.*

**CONDITIONS:** If a mare nominated to any of the above stakes has a dead foal, or more than one foal, is barren, or the foal dies at birth, the entry of such a mare is void and the nomination fee shall be returned to the subscriber. Transfer of ownership of any entry must be reported promptly. All stake races are contingent on funding. We reserve the right to make changes.
