Please find enclosed a consignor application for the CTHS (Manitoba Division) Yearling Sale.

The sale will be on **SUNDAY, AUGUST 20, 2017 @ 2:30 PM**. Following is a list of general information for sale consignors. No yearlings are allowed in the Assiniboia Downs backstretch before or after the Sale. If you have further questions regarding the sale, please contact the CTHS office @ 204-832-1702.

The 2017 catalogue will use black type cataloguing rules to meet international standards.

CONSIGNOR INFORMATION

1. The fee for each yearling consigned to the sale **by May 31 is \$236.25** (\$225 + \$11.25 gst). If nomination is postmarked **after May 31, the fee is \$446.25** (\$425 + \$21.25 gst) per yearling. **Late nominations will be accepted but must be received by June 15 or delivered in person by June 15.** Nominations will not be accepted postmarked or delivered after June 15.
 2. **All thoroughbred yearlings are eligible to enter this sale.**
 3. PLEASE **SIGN THE CONSIGNORS CONTRACT. SEPARATE CONTRACTS ARE REQUIRED FOR EACH INDIVIDUAL OWNER OR PARTNERSHIP.**
 4. Consignors must forward **ORIGINAL** Coggins papers to the CTHS office prior to sale date. Yearlings entered in the sale are required to test **Coggins negative within 60 days of the sale.**
 5. Forward **ORIGINAL** Jockey Club and Canadian registration papers prior to sale date. If you haven't checked the markings on the registration papers against the yearling, now would be the time to do so. Corrections can be made free of charge within 6 months of the issue date (see bottom right corner of registration papers), after 6 months, The Jockey Club charges \$75. This cost will be passed on to you if the yearling is sold with incorrect papers. The CTHS office will charge \$30 to process paper corrections for yearlings sold at the sale.
 6. For each horse consigned and presented for sale, regardless if the horse is sold or receives a bid, a minimum **commission of \$100 or 5% of the highest bid** or the reserve price whichever is greater, will be paid to the CTHS by the consignor.
 7. Yearlings accepted to the sale and subsequently withdrawn by the consignor without a veterinary certificate will be charged a **\$350 (per entry) withdrawal fee.**
 8. Yearlings will be accommodated in the Sale barns, situated in the Red River Ex grounds, west of the grandstand.
Instructions to the stable area:
- enter off of Portage Avenue (Hwy. #1) down Clubhouse Road, past the car dealerships, through Club House parking to Gate 4, next to the red and white CTHS sign.
Consignors can **begin stabling yearlings at noon Friday, August 18. Yearlings must be in place no later than 10:00 A.M. Saturday, August 19.**
 9. Stalls will be prepared with **shavings** prior to the yearlings' arrival. However, subsequent bedding, hay, water, water buckets, feed buckets and stall cleaning will be the consignors' responsibility.
 10. A listing of stall allocation will be posted near the entrance of the Sale barns.
 11. The Sale barn area will be closed at 9:00 P.M.
 12. The Sale barns will be open for yearling **viewing beginning Saturday, August 19 at 10:00 A.M.** Consignors are advised to clean stalls prior to the viewing period and to have personnel on hand to show the yearlings.
 13. **Leather halter** with parentage plate will be **provided.** Consignors will be billed **\$75.00** for each halter.
 14. Consignors are responsible for delivering yearlings to the Sale ring on schedule, then back to the stabling area immediately following bidding.
 15. **Consignors** are responsible for **feeding and watering** the yearlings the **entire time** they are stabled in the Sale barn, including after they return from the sale ring.
 16. The shipping-out of yearlings can begin immediately following the (their) Sale. However, no yearlings will be shipped-out between the hours of midnight August 20 to 8:00 A.M. August 21. **The Sale barns must be vacated by noon, August 21.**
